- Java 8+
- Ant
- BamQC

- pylint
- pytest

This is a pipeline using BamQC for bam file stats.

2.1.1 Running from the command line

Parameters

config [file] Location of the config file for the workflowin_metadata [file] Location of the input list of files required by the processout_metadata [file] Location of the output results.json file for returned files

Returns

output [file] Html file with all the statistics

run (input_files, metadata, output_files)

This pipeline analyses a given bam file and produces html file as the reporting output file.

Parameters

• **input_files** (*dict*) – Dictionary of file locations. These should include:

bam [str] Location for the bam file

- metadata (list) Required meta data
- **output_files** (*dict*) Locations of the output html files returned by the pipeline

Returns

- **output_files** (*dict*) Locations for the output html
- output_metadata (dict) Matching metadata for each of the files

3.1 Test Tool

class Bam_QC.tool.bamqc.**bamQC**(*configuration=None*) Tool for statistical and qualitative analysis of a Bam file

Count the number of characters in a file and return a file with the count

Parameters

- **file_in_loc** (*str*) Location of the input file
- **file_out_loc** (*str*) Location of an output file

Returns Writes to the file, which is returned by pyCOMPSs to the defined location

Parameters

- **input_files** (*dict*) Input bam file
- input_metadata (dict) Matching metadata for the file, plus any additional data
- **output_files** (*dict*) html file containing reports.

- output_metadata (dict) List of matching metadata for the returned files
